NEEDS & OBJECTIVES

SUCPD/SUU Target Audience: This one-day conference is designed to inform academic urologists involved in the development and implementation of urology residency programs. The conference should be of special interest to those physicians involved in the education, supervision and evaluation of urology residents.

SUU Needs:

1. Most urologists have a fear of social media, mostly based on a lack of knowledge.
2. Most urologists are unaware of the best practices for EMR usage.
3. Few urology centers understand the implications of ACOs on education and research.
4. Most centers want to involve residents in quality and patient safety but do not have examples or role models on how to accomplish this.

SUU Objectives: At the conclusion of this meeting, attendees should be able to:

1. Identify benefits and risks of the use of social media in medicine.
2. Describe best practices for EMR usage.
3. Explain the implications of ACO with regards to education and research.
4. Identify problems with residents participating in quality and patient safety programs and how to overcome them.

SUCPD Needs: Program Directors and Chairs need to better understand the components of the NAS and the Milestones. They need to learn about new evaluation instruments to assess where residents are in the milestones. There are certain unique features of Surgical Accreditation within the Milestones and those involved in resident education should understand these issues. The participants also need to understand how to better evaluate residency candidates and the role of research in resident education.

SUCPD Objectives: At the conclusion of this meeting, attendees should be able to:

1. Describe the composition and purpose of a Clinical Competence Committee.
2. Describe new evaluation tools for the Milestones and how they impact both the trainers and trainees.
3. Identify the components of the Milestones and how they can be implemented within a residency program.
4. Develop an approach for assessing surgical competency in open and minimally invasive surgery.
5. Assess whether research should be a required component of residency training in their own program.

1. Peer review for valid, evidence-based content of all materials associated with an educational activity by the course/program director, editor, and/or Education Content Review Committee or its subgroup.
2. Limit content to evidence with no recommendations.
3. Introduction of a debate format with an unbiased moderator (point-counterpoint).
4. Inclusion of moderated panel discussion.
5. Publication of a parallel or rebuttal article for an article that is felt to be biased.
6. Limit equipment representatives to providing logistics and operation support only in procedural demonstrations.
7. Divestiture of the relationship by faculty.


